## 1. What data does Cospe s.r.l. collect?

Cospe s.r.l. collects the following data:

- Personal identification information (e.g. name, email address, phone number, ...).
- Information regarding rental services you might need.

## 2. How does Cospe s.r.l. collect your data?

You directly provide Cospe s.r.l. with most of the collected data, namely when you:

- Voluntarily complete our contact form or send us an email.

### 3. How will Cospe s.r.l. use your data?

Cospe s.r.l. collects your data in order to:

- Answer your inquiries via email or by phone.

### 4. How does Cospe s.r.l. store your data?

Cospe s.r.l securely stores your data on password protected devices located at our administrative office and online on servers owned by Google, Inc. and protected by Two Factor Authentication (2FA).

Cospe s.r.l. will keep your data until the request to erase it or the withdrawal of consent to store it and process it.

### 5. What are your data protection rights?

Cospe s.r.l. would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- **The right to access** You have the right to request Cospe s.r.l. for copies of your personal data. Cospe s.r.l. may charge you a small fee for this service.
- **The right to rectification** You have the right to request that Cospe s.r.l. correct any information you believe is inaccurate. You also have the right to request Cospe s.r.l. to complete any information you believe is incomplete.
- **The right to erasure** You have the right to request that Cospe s.r.l. erase your personal data, under certain conditions.
- **The right to restrict processing** You have the right to request that Cospe s.r.l. restrict the processing of your data, under certain conditions.
- **The right to object to processing** You have the right to object to Cospe s.r.l.'s processing of your personal data, under certain conditions.

- **The right to data portability** – You have the right to request that Cospe s.r.l. transfer the data that it has collected to another organization, or directly to you, under certain conditions.
